

Job advertisement 'Public Affairs Manager Brussels' (m/f/d) starting 1 October 2025 – initially limited to two years (full-time, 40 hours per week / part-time possible)

- Preparing, following up and participating in consultation rounds on legislative proposals
- Preparing information for members on projects from Brussels

 Providing input for political communication with Berlin politicians on issues arising in and relating to Brussels
